When the HOA does not get the quarterly payments, it affects the annual budget and the HOA's ability to provide for the entire community. LAWN MAINTENANCE

Many homeowners are neglecting their obligation to maintain their lawn. Please cut, trim, weed, fertilize and feed your lawn properly so that you do not take away from the look of our neighborhood. There are many homeowners who work hard and take pride in maintaining their lawn. Please do not distract from them by neglecting yours.

STREET PARKING

Please note it is against our bylaws to park at the curb. Please be considerate of your neighbors and utilize your garage and driveway for all vehicles. Parking at the curb causes congestion on our streets and can be a danger if emergency vehicles cannot easily access our roads. Additionally, it decreases property values in a community to consistently have cars parked at the curb.

MAILBOXES

Information on where to purchase your community approved (existing) mailbox can be found on our website at myoakcrest.com. Anyone not utilizing the standard mailbox will be receiving a violation notice. The cost of replacement is the responsibility of each homeowner.

ARCHITECHRIAL IMPROVEMENTS

Please note that if you wish to make any changes to your home (install tiles on your walkway, paint your home, install a pool or gazebo), you must first submit a request or proposal to the ARC Committee. The committee will review your submission to ensure that it is in compliance with guidelines outlined in the By-Laws of our community and return the request to you in less than 30 days. Any home improvement done to a residence without ARC approval risks the possibility of being asked to return the change to its original condition. More detailed information about ARC requirements can be found on the community website. However, should you have any immediate question or concerns, please contact Charlotte Stein at Sentry Management.

NEIGHBORHOOD WATCH

We had the Dynamics of Neighborhood Watch meeting on November, some homeowners participated, on January 13, 2009 meeting, the Orlando Police Department will be attending to the monthly meeting for further assistance, and more volunteers.

Things you can do:

- Make sure your home is well lit at night. Trim shrubs so that criminals do not have easy places to hide
- Use your locks. Lock your home and vehicle at all times. Do not leave valuables in your vehicles or leave anything visible from the window.
- Do not leave your garage door open and unattended.
- If you see a suspicious person or suspicious vehicle parked on your street, call 911 and report it. We all know what is "normal" for our street. When you notice something our of the ordinary, take action, don't wait, pick up the phone.
- Look out for your neighbor's home. We must be eyes and ears to each other.
- Take notice of details of suspicious persons or vehicles note color of clothing, vehicle, make, model and tag number if you can.

NEIGHBORLY REMINDERS

Pet Waste – pick up after your pooch! It's the law. Orlando City code requires you to pick up after your pet. It's a nuisance, and leads to water pollution no matter where you live.

Orange County Ordinance Se. 5-50

B (9) - Fail to remove excreta from animal owner's property, resulting in offensive odors, (first offense \$ 107 fine)

C(7) – Fail to remove any excreta deposited upon public property or another person's private property by any animal within the care, custody, ownership or control of such person. (first offense \$87.50 fine)

<u>Water Pollution:</u> Un-scooped poop washes into storm drains, which drain directly to local lakes and water bodies, harming human health, wildlife and the environment.

Reduced Oxygen Levels: Decomposition of pet waste demands a high level of oxygen from water, reducing the amount of dissolved oxygen available to plants and animals – resulting in fish kills.

Algae Blooms: Pet waste adds excess nutrients like those found in cow manure to lakes – resulting in algae bloom (a stagnant blanket of green).

Take a bag with you on walks to pick up after your pet. Dispose of the waste in the toilet or trash. The community by-laws outline the proper storage of trash cans. At no time should the 96 gallon City of Orlando trash cans be stored in the front of any home. Please place the cans in your garage or at the rear of your home out of sight of the street.

Please note: A Violation Committee will be in place shortly to issue citations to homeowners who do not comply with our community By-Laws. If you are not familiar with the deed restrictions for Oak Crest, please review your By-Laws.

A friendly reminding to all homeowners:

All property damage done to the community common areas by homeowners, guest or renters, e.g. pool area/ furniture, gates, playgrounds, tennis courts, etc.; is additional money that we, *all homeowners*, have to PAY in order to repair/replaces the damages.

Homeowners be aware, the community common areas belong to each homeowners and all repair cost it equally share from each of OUR pockets.

Educate your children, guest and renters to take care our properties and to maintain our common areas clean, the HOA do not have a maintenance services to clean/collect left over garbage after anyone, be proud of your community and keep it clean. DO NOT LITTER.

Pine Castle Jeep Range Concerns

Several Oak Crest homeowners have been very involved gathering information and attending to The Army Corp of Engineers Meetings.

The Army Corp of Engineers, Parson Company, its presently conducting the mapping and digging in Oak Crest. If you have not filled out the Right of Entry Form authorizing the Army Corp to search your property, be advised that a deadline have been set do so.

Upon completion of the search the Army Corp was to provide each homeowner with a documents which would verify that a search was conducted, the Army position has changed for our communities. A general document will be provided to the City/County Tax Collector only upon completion of the search on all Pine Castle areas, that it's unacceptable, all homeowners should received a copy of the documents as well.

Therefore, in effort to assist in keeping the pressure on and making sure that Oak Crest does not fade in the shadow, please write to our government representatives and let our voices be heard.
